The Displacement Risk Ratio is a Reinvestment Fund measure that identifies areas where residents may face involuntary displacement by comparing changes in the ratio between housing sales price to median household income over time. In areas where prices rise at a rate similar to income, there is no concern about involuntary displacement; if prices rise faster than income, displacement, or the inability of households of with similar economic situations as longer-term residents to live in the neighborhood, is a potential concern worth further inquiry. *Alana Kim, Policy Analyst, Reinvestment Fund and Dr. Michael Norton, Chief Policy Analyst, Reinvestment Fund*

Kaia Peterson

Executive Director, NeighborWorks Montana

Eran has been engaged in community development and social equity work in Missoula for the last twenty years. Prior to joining the City, she served as the Executive Director of the Poverello Center, Western Montana's largest homeless service provider. Ms. Pehan has extensive experience in public outreach and engagement, social infrastructure planning and assessment, and innovative problem solving. She recently spearheaded the adoption of a comprehensive and community-driven city-wide housing policy aimed at ensuring everyone has a place to call home.
